Southeast Florida Co-Operative Contract - Solicitation No. ITB 25-017 Water Meter Fitting, Water Line Accessories, and Fire Hydrants and Accessories - Consolidated Pipe and Supply; Ferguson US Holdings; Fortiline Inc

Summary:

Requesting authorization and approval of the following:

- Authorization and approval to participate in the Southeast Florida Co-Operative Contract No. 25-017 (The City of Deerfield Beach) for Water Meter Fitting, Water Line Accessories, and Fire Hydrants and Accessories.
- 2. Authorization and approval to issue purchase orders and process payments pursuant to Contract No. 25-017 for "Water Meter Fitting, Water Line Accessories, and Fire Hydrants and Accessories" Consolidated Pipe and Supply; Ferguson US Holdings; Fortiline Inc), that may independently or aggregately exceed \$35,000.00.

Procurement:

The City of Plantation has historically been participating in publicly solicited and awarded Southeast Florida Co-Operative Contract No. 2022-006 for Water Meter Fittings and Water Line Accessories. This contract has expired (June 5, 2025) and a new contract has been provided by The City of Deerfield Beach. This new contract "Water Meter Fitting, Water Line Accessories, and Fire Hydrants and Accessories". This contract expires on June 5, 2028, with a provision for two (2) additional one (1) year renewal options.

Based upon the foregoing information, the Procurement Department is requesting authorization and approval of the following:

 Authorization and approval to participate in the Southeast Florida Co-Operative Contract No. 25-017 (The City of Deerfield Beach) for Water Meter Fitting, Water Line Accessories, and Fire Hydrants and Accessories. 2.
