TITLE: TR14075 - A Resolution of the City Commission of the City

of Tamarac, Florida, approving and authorizing annual fiscal

year expenditures of up to \$131,131.72 for equipment purchases and payments for service contracts from/to Stryker Medical Corporation which is a sole source authorized provider of Stryker power load systems and Lucas Chest Compression units utilized on all rescue vehicles, effective upon passage of this Resolution through September 2024. Authorizing the appropriate City Officials to approve renewal options; approving additional new

purchases from Stryker Medical Corporations up to a total of \$65,000 in accordance with the Tamarac Procurement Code during the current fiscal year 2024; providing for conflicts; providing for severability; and providing for an effective date.

RECOMMENDATION:

To request approval and authorize an annual fiscal year expenditure of up to \$131,131.72 for purchases and payments for service contracts from/to Stryker Medical Corp. for FY24. Stryker Medical Corporation is the sole authorized provider of Stryker Power Load Systems and LUCAS chest compression units utilized on all rescue units.

BACKGROUND:

The Fire Rescue Department has utilized Stryker Power Load Systems and LUCAS chest compression units since 2009 and 2014 respectively on all rescue vehicles due to ease of use and durability. Our vehicles are equipped with power stretchers and patient lift assist devices to improve the employee's ergonomic working conditions by reducing the workload of stretcher raising, lowering patient loading into the rescue vehicles.

To maintain compatibility consistency and standardization of existing equipment, TFR will utilize Stryker Medical Corp. as the sole authorized provider and the City's Sole Source Justification, and other necessary forms have been executed and will be forwarded to the Purchasing Department.

The purchases of LUCAS chest compression equipment for FY24 were approved by the City Manager via Memo dated December 1, 2023, for a total amount of \$37,656.54 and is attached hereto as a backup document. Additionally, TFR is requesting approval to purchase one (1) Power XT Stretcher, and one (1) Power Load Pro for a total of \$66,674.08; Stryker quote #10797315 is attached hereto as Exhibit A.

Stryker Medical Corp. expenditures for FY24 are detailed below:

The aforementioned expenditures to Stryker Medical Corp. will bring their annual aggregate spending for FY2024 to \$131,131.72; while the individual transactions are unrelated to each other; when the total spending for an individual vendor exceeds our administrative approval limit of \$65,000 during any fiscal year, it is the City's policy that we present the aggregate total spending to the City Commission for their approval so that there is complete transparency related to the City's spending.

ISSUE:

Purchases and equipment service contracts made from this vendor are part of Tamarac Fire Rescue annual equipment replacement programs and equipment service contracts. The combined purchases/service contracts payments will bring the annual aggregate spending with Stryker Medical Corporation for FY24 to \$131,131.72 therein, requiring City Commission approval.
