TITLE: TR13992 - A Resolution of the City Commission of the City of Tamarac, Florida, approving a first amendment to the interlocal agreement between Broward County and the City of Tamarac for surtax-funded municipal transportation project: Milling, Paving, and Resurfacing of Public Road/BC-TAM-FY2020-00001-attached hereto as Exhibit "1"; authorizing the appropriate city officials to take any and all actions necessary to effectuate the intent of this resolution; providing for severability; and providing for an effective date.

RECOMMENDATION: City Commission consideration and approval of TR13992 authorizing the execution of the first amendment to the interlocal agreement between Broward County and the City of Tamarac for surtax-funded municipal transportation project: Milling, Paving, and Resurfacing of Public Road/BC-TAM-FY2020-00001.

BACKGROUND: As you may know, the Broward County voters approved a 30-year, one percent surtax for transportation in November 2018, and the first distribution of surtax revenues was received by Broward County from the Florida Department of Revenue in March 2019. Subsequently, after adopting several resolutions related to the surtax revenue, the City Commission approved an Interlocal Agreement with Broward County to use the surtax fund for Capital Projects in the City. Specifically, on September 14, 2022, through Resolution No. R-2022-100, the City Commission approved the Project Funding Agreement ("PFA") for the Rehabilitation and Maintenance ("R&M") Project: Milling, Paving, and Resurfacing of Public Roads/BC-TAM-FY2020-00001("Project") for a total award amount up to \$2,817,339 (**Attachment 1**). The above referenced project consisted of milling and asphalt pavement resurfacing within the

Mainlands of Tamarac Section 1-5 Subdivision.

Since then, the City has submitted a request to expand the Project area to Hiatus Road due to the deplorable conditions of the pavement on this road by including a city-owned portion of Hiatus Road in the Project. Broward County approved the request (**Attachment 2**); as it incurs no additional costs and ensures Transportation Surtax proceeds are utilized efficiently, and responsibly.

The City has also submitted an extension and project schedule adjustment request based on unforeseen delays. An amendment to the PFA is necessary to effectuate the addition of Hiatus Road and the schedule extension.

ISSUE:

Adoption and execution of the First Amendment to the Interlocal Agreement with Broward County to provide for a schedule extension and transportation surtax funding for the expansion of project: Milling, Paving, and Resurfacing of Public Roads/BC-TAM-FY2020-00001BC-TAM-FY2020-00001, to Hiatus Road.
